Registering for the first time

In order to make an application you will need to register on our DoIT platform.

When signing up for the first time to DoIT, follow these instructions:

Step 1: Follow the instructions to apply to the fund and read the supporting documents on the following URL https://doit.life/ukyouth/fund/md/205849/the-uk-youth-fund-thriving-minds.

Step 2: Once you have read all the information click "Apply".

Step 3: Create your new organisation account (or log in if you have used Do-It to apply for a previous UK Youth Fund).

Step 5: Wait to receive email notifications from the platform about next steps.

Step 6: To view your completed application, click on the "My Applications" tile and you can see a full preview of your application.

Eligibility Quiz

The first part of the application process is to determine whether your organisation is eligible to apply to this particular fund. You must respond positively to all of the questions below to be eligible and access the application form.

Please confirm your organisation:

- 1. Is based and delivers its work in the UK.
- 2. Had an income of less than £500,000 shown in your last annual accounts.
- 3. Is a charitable or not for profit organisation and can provide a governing document stating this.
- 4. Has as its primary purpose the provision of services benefitting children/young people. At least 70% of your organisation's beneficiaries must be aged 8 25 years.
- 5. Has been operational for at least two years.
- 6. Has at least one year's full accounts that are available online or submitted with this application.
- 7. Has the appropriate processes and policies in place to keep young people safe. This must include a Safeguarding and Health & Safety Policy. We may ask to see this if you are awarded funding.
- 8. Has the appropriate insurances, qualifications or affiliations to a governing body.

 Depending on what you want to do, this could include public liability insurance,
 leaders or instructors with special qualifications, or an affiliation to a governing body.

 We may ask to see these if you are awarded funding.
- 9. Complies with the Equality Act 2010, the General Data Protection Regulation 2018 and Data Protection Act 2018, Public Services (Social Value) Act 2012 and all other relevant statutory or regulatory requirements.
- 10. If you receive a UK Youth grant you will be able to commit to engaging in and attending core activities of the fund and complete all reporting requirements.

Page 2 - About Your Organisation and Young People

The following questions have a maximum character limit of 2000, however we do not expect you to write that much for every question. Most questions should be answerable in 200 – 300 words, but if you need to say more you can.

16. Briefly explain the work your organisation does. How do you work with young people, what activities or services do you provide and how often?

Please use your own words to describe your organisation, the work you do with young people and your reach.

17. How many young people do you directly engage with over the year?

We want to know the number of young people who directly engage in your activities and services and have direct contact with your youth workers. Audience members, spectators or passive participants should not be included in your total.

18. What are the mental health and wellbeing needs of the young people you are working with and your youth workers?

What are the issues, needs and challenges faced by the individuals in your organisation, both the young people you work with and the youth workers who deliver your services. What we want to know is that you have identified a particular need or set of issues that you are motivated to tackle. We don't want you to quote government statistics or an academic report on mental health. We want to know about the issues you, your youth workers and young people are directly experiencing on the ground.

19. What is your organisation doing to meet these needs and what are the challenges that your organisation faces in achieving this?

Tell us what you have done so far to tackle the issues you've told us about in the previous question and how you hope to build on and improve your provision. If this will be a new initiative to improve mental health support for young people and youth workers then please tell us about the skills and experience you have to deliver this work. It is important to us that young people have been consulted and involved in identifying their needs and concerns as well as being engaged in the design of a solution and having been asked what they want. How do you know that the needs you have identified in the previous questions are of the greatest importance to young people and what evidence do you have that your proposals to tackle these issues are wanted by young people and youth workers.

We aim to specifically target vulnerable communities identified by mental health charities as requiring increased support and services. Although not essential, your application will score higher if a significant proportion of the young people you engage with are within these groups.

Successful applicants working with these groups will also benefit from our targeted workshops and programmes that will focus on the specific needs within these communities.

You may not be currently providing specific services for young people from these groups, but know that they make up a significant proportion of the young people you work with.

The unrestricted nature of the grant means that you will be able to spend the grant on any aspect of your organisation's operation. However, we would like you to demonstrate how the way in which you aim to spend the grant will help your organisation improve mental health support and provision for young people and youth workers. You may want to secure a youth worker's salary for the next three years to ensure consistency of provision, or free up a member of staff to engage in training. You may have an existing partnership with a mental health provider that you would like to scale up. You may have a current project or provision you want to expand or just ensure your rent is covered. The important thing is that you explain how that will lead to the overall aims that you have talked about in the previous questions.

As the grant is unrestricted and for three years you will be able to change how and on what you spend the following years' grants however you will still need to demonstrate how it will continue to achieve the aims of the programme.

You will not be able to spend the grant on:

- Retrospective costs incurred before 1 May 2022.
- Redundancy costs.
- Covering costs/losses already supported through other sources, including grants or any Government schemes.
- Onward grantmaking to individuals or other organisations.
- Costs related to campaigning or the promotion of political or faith beliefs?

23. Grant amount requested:

Please give the annual amount you are requesting from this fund. We do not want to pre-empt the responses we receive, but we are envisaging distributing annual grants of between £15,000 - £45,000. The grant amount offered to each grantee will take into account the size of your organisation, need and suitability for the programme of wraparound support that will be an integral aspect of the grant offer. It is therefore possible that you could be offered a different level of funding to that which you have requested if the decision making panel feel your request was too high or too low. If you are successful this will be the grant amount offered each year for the three year term of the grant.
